



# Camden Child, 9, Saved From Death After Lethal Shock

A nine-year-old Camden girl was snatched from the clutches of death early Friday afternoon after she was accidentally electrocuted at her home on Fair Street.

Lisa Holland, the only child of State Highway Commissioner and Mrs. Donald H. Holland, was rushed to the Kershaw County Memorial Hospital in a condition of death (she had stopped breathing and her heart had stopped beating) after she had received a lethal electric shock while sitting on a washing machine and dangling her feet into a sink at the Holland's home at approximately 2 p.m. Friday.

Dr. George West opened the child's chest and jumped the still heart with his hands for several moments, without success. The hospital's Heart Monitor Machine was then put into operation with Dr. Francis McCorkle operating the unit and with Dr. West, Dr. Sandra Catoe, and Dr. Jack Fakoury assisting.

After several minutes the heart began beating again, and as of this (Monday) morning Lisa's condition is somewhat improved, but she is still on the critical list. The Heart Monitor is being kept by her side in the event of another emergency.

Lisa and Becky Bowers had come into the Hollands' home after playing in the yard, and Lisa was washing her feet at the time of the accident. Becky was also shocked, but only slightly. Mr. Holland was at home at the time, and he rushed his daughter to the hospital, where, fortunately, Dr. West and the other physicians happened to still be attending patients.

The life-saving Heart Monitor Machine was a gift to the hospital from the hospital's auxiliary. The machine shocks the heart and regulates the pace of the beat and also prevents fluttering.

## Merchants Warned Of 'Invoice'
